Camp Guidelines:

- Horses under 3 years old are not permitted.
- Please be sure to bring a horse that you have ridden at least 40 hours and can safely walk, trot and canter while riding. As these are not colt starting camps, please DO NOT bring an unridable horse or a horse that has not been ridden in a long time. You and your horse must have met the prerequisites for the camp you're attending. If the horse you're bringing is not the horse you assessed on, you must be confident that he/she can complete all the exercises as laid out in the prerequisites. Remember that the ranch experience is more intense just because of the open, natural environment. Make sure to bring the best horse you can so you get the full experience of the lessons, trails, and all other fun things that will happen. If it is determined that your horse is unsafe in a group, you will be asked to stay behind during trail rides and other group exercises. No reimbursement will be given.
- Stallions are not permitted.
- Course 2, 3, 4 and Purpose camps have prerequisites that must be met in order for riders to participate. If you are unsure of these prerequisites, please see the Camp Overview or contact your camp host for verification.
- Personal photos are meant to be for your use only and are not to be used for public viewing or commercial purposes. Photos taken of specific people are not to be displayed without written permission by the person in the photo.
- Video cameras and other recording devices are not permitted.
- We recommend that safety helmets be worn during your participation in any Jonathan Field Horsemanship event. Riders under 18 MUST wear a helmet.
- As individual situations vary, please pass on any special requests to your Camp Host.
- Horses must have a Current Coggin's test
- Horses must be up-to-date on Vaccinations (or Riders must provide a signed "Refusal to Vaccinate Waiver")

CANCELLATION POLICY:

All monies are non-refundable.

Cancellation more than 30 days prior to the event: A \$25.00 administration fee will be charged. The remaining amount will be credited with a Jonathan Field Company Ltd. Credit Note or applied towards a camp/clinic transfer.

Cancellation within 30 days of the event: The \$500.00 deposit will be forfeited. The remaining amount will be credited with a Jonathan Field Company Ltd. Credit Note or applied towards a camp/clinic transfer.

Jonathan Field Company Ltd. Credit Notes can be used towards Jonathan Field Horsemanship equipment or Jonathan Field Horsemanship DVD's. Camp/Clinic transfers are valid for ONE transfer only and must be used within the following calendar year. Credit Notes are valid for one year after date of issue.
